StuDocu.com SCHOLARSHIP CONTEST

OFFICIAL RULES AND ELIGIBILITY

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. The StuDocu.com Scholarship Contest (the "Contest") is sponsored by StuDocu.com (StudeerSnel BV) ("StuDocu"). StudeerSnel BV is a company which offers an online Platform which gives users the possibility to exchange Study Material among themselves, hereafter "StuDocu.com". This Platform is defined further in the Terms of Use. StuDocu.com is governed by Dutch law, has its registered offices at Nassaukade 350E, 1053 LX Amsterdam and is registered at the Dutch Chamber of Commerce with company registration number 56829787.

ELIGIBILITY:

Subject to these Official Rules, the Contest is open only to permanent legal U.S. residents physically residing in the fifty (50) United States of America and the District of Columbia, who are: (i) at least 16 years old as of the date of entry; (ii) currently enrolled in an accredited college or university in the United States, as listed on the U.S. Department of Education website, available at <http://ope.ed.gov/accreditation/Search.aspx> and (iii) registered StuDocu.com users who have submitted an entry at <https://studocu.com/en/scholarship> by submitting a written response to the Contest question. The response must be between 200-300 words. Minors between the ages of 16 and 17 (inclusive) must first obtain the consent of their parent or legal guardian to enter. Scholarship awards will not be paid to institutions outside the U.S. Employees of StuDocu.com (StudeerSnel BV) and their respective parents, affiliates, subsidiaries, and advertising and promotion agencies and any other entity involved in the development or administration of this Contest, and their immediate family members or household members are not eligible to participate in or win the Contest. THE CONTEST IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW OR WHERE BONDING, REGISTRATION, OR OTHER REQUIREMENTS WOULD BE REQUIRED BUT HAVE NOT BEEN MET, OR WHERE THE METHODS OF ENTRY SET FORTH BELOW WOULD BE DEEMED CONSIDERATION. THIS AGREEMENT IS GOVERNED EXCLUSIVELY BY DUTCH LAW.

CONTEST OVERVIEW:

StuDocu.com will open the contest online on September 16, 2019 at 00:01 CET at <https://studocu.com/en/scholarship> and allow registered, eligible entrants to submit a response between 200-300 words. StuDocu will select one winner and one runner-up with the best responses

from among all Contest entrants. The Contest winner will receive a first prize of \$2,000 Scholarship, the Contest runner-up will receive a second prize of \$1,000 Scholarship.

ENTRY PERIOD:

The Contest will begin at 00:01 CET, starting on September 16, 2019, and will end at 23:59 CET on November 30, 2019 (“Entry Period”). The deadline to submit entries for the Contest will be displayed on the Contest entry page. Once the deadline has passed, no further entries for the Contest will be accepted. StuDocu will announce the winner on social media and/or its website within four weeks of the end date of the Contest. StuDocu reserves the right to change any beginning or end dates of the Contest at any time. StuDocu also reserves the right to discontinue the Contest at any time.

HOW TO ENTER:

No purchase or payment is necessary to participate in the Contest. Participants must agree to the StuDocu.com (StudeerSnel BV) terms of use and register on StuDocu.com. During the Entry Period, participants may enter the Contest by visiting <https://studocu.com/en/scholarship> and submitting a written response to the Contest question. Entrants who have completed the foregoing step will be eligible to win either a \$2,000 or \$1000 scholarship in the Contest. Entrants must also meet all other eligibility requirements contained in these Official Rules.

The Contest question response must be between 200-300 words. You may only submit one entry. Multiple entrants that submit the same response will be disqualified. Any late, lost, misdirected, incorrect or incomplete entries will be disqualified and StuDocu and its agents will not be responsible for such entries. StuDocu expressly reserves the right to disqualify any entries that it believes in good faith are generated by an automated means or scripts, or that are the result of plagiarism. Entries generated by script, macro or other automated means are void. By entering you agree to accept and be bound by all terms and conditions in these Official Rules.

DISCLAIMER: The Contest is in no way sponsored endorsed, or administered by, or associated with, Facebook, Twitter or Instagram. Facebook, Twitter or Instagram shall not be liable in any way in connection with the Contest and you hereby release Facebook, Twitter, Instagram, or WordPress from any and all claims, damages, and liability in connection with the Contest.

SELECTION OF WINNERS:

One or more Judges from StuDocu shall read each of the eligible Contest entries and select one winning response and one second place response. The Judge(s) shall base their decision on the following criteria: sincerity, creativity, thoughtfulness, and factual credibility. Odds of winning depend on the quality of your response as evaluated by the StuDocu Judge(s). The Contest will be

conducted under the supervision of StuDocu. The decisions of StuDocu are final and binding in all matters relating to this Contest.

SCHOLARSHIPS:

The Contest winners will receive either a \$2,000 (first place) or \$1,000 (second place) Scholarship to be applied toward tuition at the college or university in which they are enrolled. Each winner will only receive one Scholarship. In no event shall StuDocu be obligated to award any prizes other than the Scholarship specified in these Official Rules. The Scholarships are non-transferable and no substitutions (including, without limitation, for cash) are permitted. Winners shall be solely responsible and liable for all federal, state and local taxes, and any other costs and expenses, associated with the Scholarships.

CLAIMING YOUR SCHOLARSHIP:

Contest winners and runners-up will be notified by email; provided, however, that StuDocu reserves the right to determine an alternate method of notification. Failure to provide accurate contact information may result in disqualification, and if unable to contact a winner within 72 hours, StuDocu may in its discretion award a Scholarship to any other eligible contestant.

Scholarships will be awarded to the winner(s) and paid directly to their accredited college or university for tuition for the semester following their win. Winners are required to provide StuDocu with the following information if requested:

- Your StuDocu username and profile URL;
- Your residential address and phone number;
- Your student identification card at your enrolled college or university;
- Your current or most recent transcript from your enrolled college or university;
- Contact and mailing information for your college's or university's financial aid office.

No payment of any Scholarship will be granted until StuDocu is able to verify with the winner's financial aid department that you are enrolled at the institution. Winners must cooperate with StuDocu and their institution in filing or providing any necessary paperwork or other materials or signatures deemed necessary by StuDocu or the institution in their discretion to process the Scholarship. Any Scholarship won by an eligible minor will be awarded in the name of a parent or legal guardian. StuDocu may, in its sole discretion, decline to award payment of the Scholarship in the case of a winner's failure to provide information in a timely fashion requested by StuDocu or the institution, or if the student's enrollment lapses for any reason.

PAYMENT DIRECTIONS:

StuDocu will pay the Scholarship directly to the U.S. accredited college or university of eligible winners in one lump sum. No Scholarship moneys will be paid directly to the winners. StuDocu has the sole discretion and final word over the timing and manner of any scholarship payments. Winners will be responsible for providing a letter of enrollment from the college or university where the Scholarship will be directed.

GENERAL CONDITIONS AND RELEASES:

By entering the Contest or accepting a Scholarship, you agree to conform to all Dutch laws and regulations. When applicable, the winner may be required to execute and return (and winning may be conditioned upon the winner executing and returning) to StuDocu, within ten (10) business days, an Affidavit of Eligibility and a Liability and Publicity Release drafted by StuDocu to be eligible for the Scholarship or an alternate winner will be selected. Winners may be required in StuDocu's sole discretion to complete relevant tax forms as a condition to the delivery of the Scholarship. Winner may also be required to furnish proof of identity, address and birth date in order to receive a Scholarship.

Unless prohibited by applicable law, your submission of an entry to the Contest or acceptance of a Scholarship constitutes your permission to use your name, photograph, likeness, voice, address (city and state), testimonials, and any other information provided to StuDocu in connection with the Contest in all media, in perpetuity, in any manner StuDocu deems appropriate for publicity purposes without any compensation to such entrant or any review or approval rights, notifications, or permissions; and constitutes your consent to disclose your personally identifiable information to third parties (including, without limitation, placing the winner's name on a winner's list).

By entering the Contest, you agree to and hereby do release and hold harmless StuDocu and its respective parents, subsidiaries and affiliated entities, directors, officers, employees, attorneys, agents, and representatives from any damage, injury, death, loss, claim, action, demand, or other liability (collectively, "Claims") that may arise from your acceptance, possession and/or use of any awarded Scholarship or your participation in this Contest, regardless of whether such Claims, or knowledge of the facts constituting such Claims, exist at the time of entry or arise at any time thereafter. Any person attempting to defraud or in any way tamper with this Contest or with StuDocu's website may be prosecuted to the full extent of the law. StuDocu reserves the right to modify these Official Rules in any way or at any time. StuDocu reserves the right, in its sole discretion, to cancel or suspend this Contest should viruses, bugs or other causes beyond their control corrupt the administration, security or proper operation of the Contest. In the event of cancellation or suspension, StuDocu shall promptly post a notice on StuDocu's website to such effect. This Contest shall be governed by Dutch law, without regard to conflicts of laws provisions. BY PARTICIPATING IN THIS CONTEST, YOU AGREE THAT ANY DISPUTE OR LITIGATION ARISING FROM OR RELATING TO THIS CONTEST WILL BE SUBMITTED TO THE COMPETENT COURT IN THE JURISDICTION (ARRONDISSEMENT) OF AMSTERDAM, THE NETHERLANDS. Notwithstanding the foregoing, StuDocu may seek equitable relief in any court of competent jurisdiction. If any provision of these rules is held to be illegal or unenforceable, such provision shall be limited or eliminated to the minimum extent necessary so that these rules otherwise remain in full force and effect and enforceable.
